CONSIDERING the Status Conference that took place with the parties and the Accused on 9 February 2006;


NOTING that the parties completed the presentation of evidence on 9 February 2006;


THE CHAMBER HEREBY ORDERS

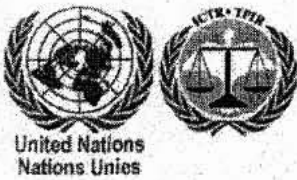
